Site: Plaster Sports Complex, Grand and National Streets, Southwest Missouri State University.
Dates: Thursday, October 25 through Sunday, October 28, 2001. Bear Bash events will begin on Friday, October 26.

Entry Fee: \$50 per player for Women's Classic (must be a USHA member, and women's entrants are guaranteed three matches, thus only one event allowed).

\$40 per player for Bear Bash first event (add \$5 if not USHA member),
\$10 additional for second Bear Bash event. The Bear Bash raises funds for the SMSU Handball Team; donations are gladly accepted.

\$15 for Junior events and students in Bear Bash tournament.

Entry fee must accompany entry. Fee includes tournament souvenir, food and beverage, and Saturday banquet (banquet guests \$10 each, payable at tournament check-in). The tournament committee may combine events if less than four players enter a division.

Deadline: Entries must include fees and be received by Friday, October 19.

Rules: Current USHA rules will apply, including losers refereeing and mandatory use of eye protection.
